### Introduction

This policy aims, where reasonably possible to:

- Safeguard the owner of any vehicle who has approval to bring their vehicle onto the Testwood School site.
- Protect the safety of all students, adults and visitors using the premises as well as the property belonging to Testwood School.

The Trustees, whilst providing car parking, motor bike and cycling provision on the school site, cannot accept any responsibility or liability for damage to any vehicle, or accidents that occur at any time on the Testwood School site.

Whilst every effort will be made to provide secure parking, the Trustees cannot accept liability for any theft or damage to vehicles utilizing the parking facilities.

At all times, owners of vehicles must respect the safety of pedestrians and other vehicles using, parking or accessing/exiting the Testwood School site. All speed restrictions and safety notices must be respected and adhered to.

All vehicle owners must register the details of their vehicles with Testwood School.

Students wishing to bring motor bikes or mopeds onto the Testwood School site must first seek the permission of their Year Leader and complete an Application for Motor Bike/Moped Permit Form signed by the Student and their Parent/Carer.

***They must then provide registration, insurance and driving licence documents to the Site Manager, who will then issue them with a permit, before they will be allowed to use the allocated student parking facilities in the car park.***

**The issue or withdrawal of a motor bike/moped permit is within the absolute discretion of the Head Teacher. Any unsafe driving behaviour or breaches of road rules will be reported to the police.**

**Electronic Scooters are prohibited from Testwood School site.**

This policy was approved by the Trustees and will be reviewed annually.
